DAHD,GoI wide F.No.N-04003/41/2022-Cattle Div. dt 27.03.2023 had approved a grant for establishment of liquid nitrogen supply system in the country under Rashtriya Gokul Mission (RGM) .The National Dairy Development Board (NDDB) has been constituted as a body corporate and declared as an institution of national importance by an Act of India's Parliament. NDDB Dairy Services (NDDB DS) is a wholly owned subsidiary of the National Dairy Development Board (NDDB). Alamadhi Semen Station is one of the semen stations under NDDB Dairy Services. NDDB DS, Alamadhi semen station having its Office located at Upparapalayam Road, Edapalayam Post, Near Redhills, Chennai -600052, Tamilnadu on behalf of the service recipient. ### 1. **BID PRICE**

- The contract shall be for the full quantity as described above. Corrections, if any, shall be made by crossing out, initialing, dating and rewriting.
- The price bid shall be submitted in the format enclosed at Price bid
- The rates quoted by the bidder shall be fixed and shall not be subject to adjustment on any account.
- The prices shall be quoted in Indian Rupees only.

3. Each bidder shall submit only one quotation. Bidder shall not contact other Bidders in matters relating to this Quotation.

### 4. **Validity of Quotation**

Quotation shall remain valid for a period not less than 60 days after the deadline date specified for submission.

### 5. **Evaluation of Quotation**

The Purchase Committee of Alamadhi Semen Station will evaluate and compare the quotations determined to be substantially responsive i.e. which

- (a) are properly signed; and
- (b) Conform to the terms and conditions, and specifications.

**GST, Packing, Forwarding, Freight & Insurance charges in connection with sale of goods shall be taken into account in evaluation.**

**Evaluation of bids can be carried out on overall basis or Line item basis. Decision taken by Alamadhi Semen Station, Alamadhi would be final and bidders have to abide by that.**

6 **Award of contract**

**The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest price with technically approved from user department of Alamadhi Semen Station.**

7 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

8 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order.

9 **TERMS OF PAYMENT:** 30 days after full installation

10 **Warranty** as per OEM

11. **Inspections and Tests:** Stage-wise inspection and pre dispatch inspection (to check compliance to technical specifications defined in RFQ) may be carried out by the Purchaser or an agency appointed and paid by Purchaser for this purpose.

12. **Delays in the Supplier's Performance:** Delivery of the Goods shall be made by the Supplier in accordance with the time schedule prescribed by the Purchaser in the Purchase Orders. If at any time during performance of the Purchase Order, the Supplier should encounter conditions impeding timely delivery of the Goods the Supplier shall promptly notify the Purchaser in writing of the fact of the delay, it's likely duration, and its cause(s). As soon as practicable after receipt of the Supplier 's notice, the Purchaser shall evaluate the situation and may at its discretion extend the Supplier 's time for performance, with or without liquidated damages, in which case the extension shall be ratified by the parties by amendment of the Purchase Order.

13. **Liquidated Damages** for Delay: Subject to Clause 12, if the Supplier fails to deliver any or all of the Goods within the period(s) specified in the Purchase Order, the Purchaser shall deduct from the Purchase Order Price, as liquidated damages, a sum equivalent to 0.5% of price of the delayed Goods for each week or part thereof of delay until actual delivery up to a maximum deduction of the 10% of the Purchase Order price. Once the maximum is reached, the Purchaser may consider termination of the Agreement or the Purchase Order.
