DAHD,GoI wide F.No.N-04003/41/2022-Cattle Div. dt. 31.10.2023 had approved a grant for Strengthening of Central Cattle Breeding Farm (CCBF) under Rashtriya Gokul Mission (RGM) at AlamAdhi in TAMILNADU.

The National Dairy Development Board (NDDB) has been constituted as a body corporate and declared as an institution of national importance by an Act of India's Parliament. NDDB Dairy Services (NDDB DS) is a wholly owned subsidiary of the National Dairy Development Board (NDDB). Alamadhi Semen Station is one of the semen stations under NDDB Dairy Services.

NDDB DS, Alamadhi semen station having its Office located at Upparapalayam Road, Edapalayam Post, Near Redhills, Chennai -600052, Tamilnadu now invites vendors for the supply of following Male sheep Breeds

1. ELIGIBILITY CRITERIA:

Bidder intending to bid shall fulfil the following eligibility criteria:

- I.** Shall be suppliers/ NGO's/ Trusts/ Co-operative societies/ organizations having experience in dealing with supply of sheep/goat to Govt. institutions, Cooperatives or to individual Farms. (Certificate of Incorporation)

- II. Should have the experience of minimum five years in the animal supply.
- III. Should have holding station capacity to keep at least **100 lambs** with feeding and watering facilities and should have fodder storage go down (Self-Declaration).
- IV. Should not be black listed or debarred by any Ministry/Department of the Govt. of India/State Govt. for participation in tenders/contract on the date of opening of EoI either in their individual capacity or as members of the firm. (Self-Declaration)

2. SCOPE OF WORK:

1. Criteria for selection of Animals

- a. Breeds- Nellore Jodipi, Vembur, Madras Red
- b. **Male lambs** less than 6 months of age will be selected.
- c. Phenotypic (physical) characters should be true to breed character. Animals with body condition score of 3.0 and above should be selected.
- d. Animals must be in sound physical condition without any deformity, abnormalities in gait.
- e. All the animals must be male
- f. The animals must be vaccinated against Brucellosis, FMD+HS and Sheep pox
- g. Health status- Clause 6
- h. The supplier should be ready to deliver the animals to destination within a month

Final selection of animals will be done by a technical team of the Buyer or its representative who has the absolute right to accept or reject an animal.

2. Management of Animal at the Dispatch Holding Stations

- a. Till dispatch, all animals will be managed by supplier including treatment if required.
- b. Before dispatch of the lambs, deworming and vaccination will be carried out by the supplier at his holding station.
- c. All type of logistic, consumables and disease testing charges will be borne by suppliers.)
- d. The supplier will make arrangement of workers for managing all animals at holding station. The salary to the workers will be paid by supplier.

3. Transportation

- a. Loading & unloading (including local transport) of animals to the delivery location will be done by the supplier.
- b. One attendant per 100 animals trained in feeding, watering and management of goats/sheep will be provided by the Supplier during transportation of animals.
- c. Water, Dry/green fodder & goat/sheep feed should be made available during transport of animals or at the mid-way holding station hired by suppliers.
- d. The supplier will make arrangement of workers for managing the animals during transport.
- e. The salary to all the workers will be paid by supplier.
- f. Veterinary First Aid / treatment should be available during entire transport.
- g. All animals must be insured during transit.

4. Management of the animals at the destination holding farm

- a. The supplier will hire a holding station for unloading and keeping the animals at the destination location till the time they are selected.
- b. Till selection, all animals will be managed by supplier including treatment if required.
- c. The supplier will make arrangement of workers for managing all animals at holding station. The salary to the workers will be paid by supplier.

5. Payment

- a. Upon final selection, the lambs will be loaded on the vehicle and 60% payment of these animals will be initiated. Once these animals are received at destination in good condition, the remaining 40% payment will be done.

Note: During entire contract period if incidence of any unlawful financial transaction, middle man commission or corruption comes to the notice of the buyer, the entire contract will be cancelled

6. Supply for CCBF

1. Supply should be at the destination location –CCBF Alamadhi (Chennai)
2. The supplier will hire a holding station for unloading and keeping lambs (till selection).
3. Lambs should have erupted all sets of milking teeth.
4. The animals should all weigh above 18 kg
5. Animals should be free from Brucellosis, FMD+HS and Sheep Pox.
6. The lot must be routinely dewormed. This should be done as per deworming plan of the supplier in order to avoid anthelmintic resistance in the animals

Tender Related Information

- a) The contract shall be for the full quantity as described above. Corrections, if any, shall be made by crossing out, initialing, dating and rewriting. The price bid shall be submitted in the format enclosed at Price bid
- b) The rates quoted by the bidder shall be fixed and shall not be subject to adjustment on any account.
- c) The prices shall be quoted in Indian Rupees only.

2. Each bidder shall submit only one quotation. Bidder shall not contact other Bidders in matters relating to this Quotation.

3. Each bidder will provide the details as mentioned Vendor Registration form in annexure I

4. Validity of Quotation

Quotation shall remain valid for a period not less than 60 days after the deadline date specified for submission.

5. Evaluation of Quotation

The Purchase Committee of Alamadhi Semen Station & CCBF Alamadhi will evaluate and compare the quotations determined to be substantially responsive i.e. which

- (a) are properly signed; and
- (b) Conform to the terms and conditions, and specifications.

GST, Packing, Forwarding, Freight & Insurance charges in connection with sale of goods shall be taken into account in evaluation.

Evaluation of bids can be carried out on overall basis or Line item basis. Decision taken by Alamadhi Semen Station, Alamadhi would be final and bidders have to abide by that.

6. Award of contract

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest price with technically approved from user department of Alamadhi Semen Station/Incharge CCBF Alamadhi

7 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

8 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order. 9.

- I. Bids must be written in English.
- II. Technical Bid received after the deadline for submission of Bid will be rejected outright and bidder will have to collect their bid document at their own expenses.
