1. Objectives:

The EOI should be accompanied by a refundable EMD of **Rs. 120000/- (One Lakh Twenty Thousand only)** in the form of demand drafts drawn in favour of **"NDDB DS ALAMADHI SS" or Bank Guarantee of same value.** The Organisation reserves the right to reject any/all applications without assigning any reasons thereof. 4. ELIGIBILITY CRITERIA:

Bidder intending to bid shall fulfil the following eligibility criteria:

- I. Shall be suppliers having experience in dealing with Embryos to Government institutions, Dairy Cooperatives or to individual Dairy Farms. (Certificate of Incorporation).
- II. Should have minimum average Turnover of **Rs. 1.2 crore (One Crore Twenty Lakhs)** (Audited Balance sheet/ITR) in the last three years (FY 2021-22, 2022-23 & 2023-24).
- III. Should have undertaken transaction of established of minimum **200 pregnancies through Embryos** in any of the last three financial year. (Copies of Purchase order/Contracts/Invoice)
- IV. Should not be black listed or debarred by any Ministry/Department of the Govt. of India/State Govt. for participation in tenders/contract on the date of opening of EIO either in their individual capacity as members of the firm. (Self-Declaration)

5. BIDDING PROCEDURE:

The supplier shall ensure performance tests be carried out in the presence of and to the satisfaction of purchaser. Necessary equipment/tools required for performance test shall be arranged at site by the supplier.

➤ For imported embryos pregnancies establishment

- The average somatic cell count (SCC) of donor cow's or heifer's dam shall be below the prescribed limit average of the concerned breed in the exporting country or its appropriate breeding value or somatic cell score (SCS) may be considered if SCC is not available.
- Should have positive GEBVs (Genomic Estimated Breeding Values) for total milk yield, total milk fat and total milk protein and reliability of breeding value for these production characters shall be more than 80% for both HF and Jersey.
- should have positive GEBV for type characters like udder, feet and leg confirmation.
- Semen of sire used for inseminating donor cow or heifer (genomically tested or non-tested) for embryo production shall meet the specifications for semen as mentioned by Government of India.
- Donor shall be free from all known breed specific genetic disorders including Bovine Leukocyte Adhesion Disease (BLAD), Deficiency of Uridine Monophosphate Synthase (DUMPS), Citrulinemia (Deficiency of Argininosuccinate Synthetase), Factor XI Deficiency, Complex Vertebral Malformation (CVM) and Brachyspina.
